- Act as assistant teacher in swimming lessons and support the lead Swimming Teacher to ensure that comprehensive teaching plans are followed and delivered according to the relevant framework.
- Assist the lead Swimming Teacher with continuous assessment.
- Mentor and aid the development of volunteers.
- Commit to personal development to keep up to date with relevant qualifications.
- Consider and act in accordance with current legislation in terms of Child Protection and Health & Safety when delivering, planning, and evaluating.
