Core purpose of role

Using your knowledge and experience within the sport advertised you will support with planning and delivery of inclusive, safe, and effective coaching sessions for a range of participants, using appropriate equipment and methods.

Coaching hours will be provided and agreed in advance with the Junior Sport Manager and Head Coach. Hours will be determined and available based on the timetable of provision for each Junior Sport programme.

Our Junior Sport - Casual Coaches are casual members of staff who are integral ensuring that Cardiff Met Sport can provide best in class service to our customers.

Key responsibilities and contributions

1. Plan, deliver, and continuously evaluate and review engaging and progressive coaching sessions.
2. Plan and record activities that will help the participants achieve their aims.
3. Support the Head / Lead Coach to plan and safely prepare inclusive coaching activities appropriate to the participants.
4. Provide the Head Coach and Junior Sport Manager with any data relating to assessments and attainment levels for participants. Providing advice on any changes in term of the children progressing to the next stage or level.
5. Assist the Head Coach or Junior Sport Manager in ensuring that the service provided is always operated in accordance with the current legislation and statutory requirements, in particular, child protection and Health & Safety



6. Support the Head coach to prepare safe activity areas using your knowledge of how to safely set up, dismantle and store equipment.
7. Use your knowledge of industry legislation, organisational policies and procedure and best professional practice to provide a best-in-class service.
